



LISTING AGREEMENT

To be a candidate to be listed with M & B we need to receive:

1. A completed Listing Agreement
2. A selection of professional or at least professional looking photographs of the applicant.

We know from experience that the better quality the photos are, the better it will be for you to be seen by our members. We generally recommend headshots as well as full-length body shots and/or activity shots.

Your photos must be "current" (within the last year), 5x7's or larger and you must be pictured by yourself in the photo. We will not accept any photos without the following information written on the back.

1. Name
2. Email address
3. Approximate date the picture was taken

M & B will not accept any of the following:

1. Photographs emailed to M & B
2. Color or Black & White copies of pictures
3. Any pictures with nudity

What happens when we receive your photos & Listing Application?

We will review your information and contact you for an appointment as soon as we have a member that we feel would be a good match for you. Please do not call or email our offices as it slows down the process.

Only those who have sent Hardcopy Photos and a completed and signed Listing Agreement will receive an appointment.

OUR PRIVACY POLICY

Once permission is given you will then mutually decide what the best meeting criteria is for both parties.
